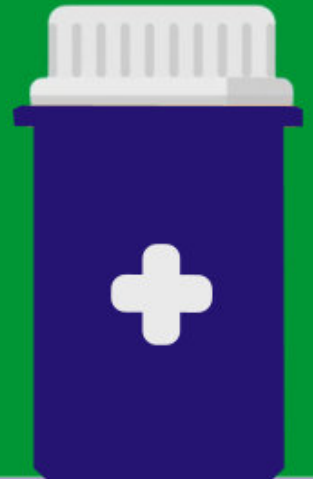
## Our Vision

## Fundusyl

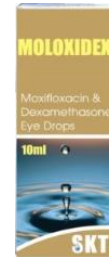
Used for cycloplegia for diagnostic procedures & mydriasis.

## Moloxidex

Moloxidex is indicated for steroid-responsive inflammatory ocular conditions which a corticosteroid is indicated and where bacterial infection or a risk of bacterial ocular infection exists. The combination can also be used for post operative inflammation associated with infection.

## Zinchlor

Relief discomfort and congestion occurring with minor eye irritation due to hay fever, dust, smoke, smog, colds, wind, sun, swimming. Ocular itching, redness and tearing.



## Aqua Tears

Artificial tear treatment for both mucin-deficient and aqueous-deficient dry eye conditions.



## Mofenac

Used in the treatment of pain and inflammation following cataract surgery.



## Oculatan

It is indicated for the reduction of intra ocular pressure in patient with open angle glaucoma or ocular hypertension and work by regulating the flow of fluid within the eye that results to lowering pressure.



## Timolol Maleate

It is indicated for the treatment of high pressure in the eye in patients with open angle glaucoma and ocular hypertension. It works by decreasing the amount of fluid within the eye.



## Dorzoptol

It is indicated for the treatment of high ocular pressure by lowering the pressure inside

the eye in order to prevent blindness in patient with open angle glaucoma and ocular hypertension.



## Norotadin

it is indicated for the treatment of sign and symptom of allergic conjunctivitis.
